Debating Higher Education: Philosophical Perspectives is a new book series launched by Springer and is motivated by two considerations.

Higher education has become a huge matter globally, both politically and socially, commanding massive resources, national and cross-national decision-making, and the hopes of many. In parallel, over the last four decades or so, there has been a growing interest in the academic literature in grappling with technical issues in and around higher education. In particular, work has developed drawing on philosophical perspectives and social theory. This is evident right across the world, especially in the journal literature and in research students' doctoral theses. In effect, we have witnessed the formation of a new sub-discipline, a shorthand of which is 'the philosophy of higher education', and which includes perspectives drawn not only from philosophy and social theory but also feminism, ethics, geopolitics, learning theory, and organizational studies.

Through this book series – the first of its kind – the editors want to encourage the further development of this literature. We are keen to promote lively volumes which are informed about changing practices and policy frameworks in higher education and which engage seriously and deeply with matters of public interest, and are written in an accessible style.

Books will take a variety of forms, and will include both sole-authored and multi-authored formats. Importantly, each volume will have a dialogical flavour, engaging explicitly in dialogue with contemporary debates and their contending positions and, where practicable, especially in volumes with many contributors, will themselves exemplify dialogue.

The editors are keen that the series is open to many approaches. We wish to include work that focuses directly on the university as a social institution and on higher education as an educational process; on the idea of the university and on higher education as a sector with political and policy frameworks; on students and learning, and on academics and academic knowledge; and on curricula and pedagogy, and on research and knowledge processes.

Volumes will examine policy and practical issues including, for example, internationalisation, higher education as a set of 'public goods', access and fairness, and the digital era and learning as well as more conceptual and theoretical issues such as academic freedom, ethics, wellbeing, and the philosophy of social organizations.

Her publications include *Philosophy and Theory in Educational Research: Writing in the Margin*, with Professor Amanda Fulford (Routledge, 2016); *Citizenship for the Learning Society: Europe, Subjectivity, and Educational Research* (Wiley, 2016); *Manifesto for a Post-Critical Pedagogy*, with Dr. Joris Vlieghe and Dr. Piotr Zamojski (Punctum Books, 2018); and most recently *Philosophical Presentations of Raising Children: The Grammar of Upbringing*, with Dr. Stefan Ramaekers (Palgrave 2019).

Jarosław Jendza is a Researcher and Lecturer in the Education Department at the University of Gdańsk, Poland, where he teaches and researches in social science research methods, higher education, as well as the Montessori method. His research also includes qualitatively oriented studies of university cultures. His recent publications address the issue of relationships in academia – particularly those between academics and students: *The Cultures of University* (2019); *The Potentials and Obstacles of Being in Dialogue at University* (2016); *The Troubadours of Knowledge and the Development of Contextualized University Studies* (2016, with P. Lavinia Marin is Lecturer in the Ethics and Philosophy of Technology Section at TU Delft where she is involved in a research project on teaching ethics to engineering students through case-based studies. Besides researching the particular difficulties of eliciting critical thinking in ethics education, her wider research interests concern mediated epistemology: how thinking and knowledge are mediated via (digital) technology, practices, and embodiment. Her latest articles are “Two Modes of Non-thinking. On the Dialectic Stupidity-Thinking and the Public Duty to Think” in *Revue Roumaine de Philosophie* (2018) and, together with Jan Masschelein and Maarten Simons, “Page, Text, and Screen in the University: Revisiting the Illich Hypothesis” in *Educational Philosophy and Theory* (2018).

Hans Schildermans is a Postdoctoral Researcher in University History and Theory at the University of Leuven, Belgium, where he teaches and researches in philosophy of education. In his doctoral dissertation, he focused on the relationship between university and society. Drawing on the pragmatic philosophies of Isabelle Stengers and Donna Haraway, as well as the work of the experimental university Campus in Camps, he conceives of the university as an ecology of study practices.

Łukasz Stankiewicz is an Assistant Professor in Pedagogy at Ateneum University in Gdańsk, Poland. His research interests lie primarily in the area of higher education studies (policy and institutional change, the interactions between the higher education institutions, the state, the market, and the class system). His publications include *Wizje uniwersytetu w polskiej debacie publicznej 2007–2010 (Visions of the University in Polish Public Debate 2007–2010)* (Impuls, 2018); “Future Perfect? Conflict and Agency in Higher Education Reform in Poland,” with Professor Tomasz Szkudlarek (2014); and “The Truths of Business and the Lies of Academia: The

Order of Discourse on Higher Education in Poland,” with Professor Helena Ostrowicka (2018).

Christiane Thompson is Professor of Theory and History of *Bildung* and Education at the Goethe University Frankfurt in Germany. Her main areas of research lie in the philosophy of education. In her research she relates systematic and historical perspectives in order to provide a well-reflected and critical framework for education and *Bildung*. Furthermore, her work focuses on power relations within educational processes with a particular emphasis on authorization practices and subject formation. She has recently published *Researching the Global Education Industry: Commodification, the Market and Business Involvement* (Palgrave, 2019, with M. Parreira do Amaral and G. Steiner-Khamsi) and *Subjektivierung: Erziehungswissenschaftliche Theorieperspektiven* (BeltzJuventa, 2019, with N. Ricken and R. Casale).

Joris Vlieghe is an Assistant Professor of Philosophy and Theory of Education at KU Leuven, Belgium. With Naomi Hodgson and Piotr Zamojski, he recently published a *Manifesto for a Post-Critical Pedagogy* (Punctum Books 2018) and, with Piotr Zamojski, *Towards an Ontology of Teaching. Thing-centered pedagogy, affirmation and love for the world* (Springer 2019). He is also interested in the impact of digital technologies on education, and more specifically in how fundamental notions such as schooling, attention, community, transformation, literacy and creativity change when a culture of the screen is (rapidly) substituted for a culture of the book.

Piotr Zamojski is an assistant professor at University of Gdańsk, Poland. He has authored four books, including two recently written in collaboration with Naomi Hodgson and Joris Vlieghe, *Manifesto for a Post-Critical Pedagogy* (Punctum Books 2017), and with Joris Vlieghe, *Towards an Ontology of Teaching: Thing-Centered Pedagogy, Affirmation and Love for the World* (Springer 2019). He has also published on issues of the bureaucratization of education, totalitarianism and educational theory, building a public sphere around education, and the role of cultural codes in schooling.
